On March 20, 2020, I mistakenly filed Articles of Incorporation for Native Earth Essential Inc., a Florida Profit Corporation (the "Florida Corporation"). I had intended to file an application for Native Earth Essentials, Inc., a Delaware Corporation, to conduct business in Florida (the "Delaware Corporation"). Upon realizing that I had filed the incorrect form, I filed a voluntary dissolution of the Florida Corporation on April 2, 2020.
