Pursuant to the Virginia Stock Corporation Act, as amended (the "Act"), the undersigned, on behalf of DESIGN STORAGE & HANDLING, INC., a Virginia corporation (the "Corporation"), states as follows:

- 1. The current name of the corporation is DESIGN STORAGE & HANDLING, INC.
- 2. Article I of the Articles of Incorporation of the Corporation is amended so that the only sentence in Article I is deleted and the following is substituted therefor:

"The name of the Corporation is Hubtex North America, Inc. (hereinafter referred to as "the Corporation")."

- 3. The foregoing amendment was duly adopted by unanimous written consent of the board of directors of the Corporation on January 15, 2024. Shareholder approval of the foregoing amendment was not required pursuant to Section 13.1-706 of the Act, which authorizes adoption of this amendment by the board of directors of the Corporation without shareholder approval.
