To Whom It May Concern,

I am writing on behalf of AvMap Satellite Navigation Inc., EIN: 04-3260354 ("AvMap" or "company"). AvMap was incorporated in Massachusetts in 1995 and is a distributor of electronic devices and accessories for cars and light aircrafts. The company's address is c/o Eugene Curry, 3010 Main Street, Barnstable, Massachusetts 02630.


Due to a reorganization of administration and logistics AvMap started to hold inventory of its products at a third-party company address in Florida since November 16, 2016, meaning that products are stocked in Florida and shipped out from Florida to customers with a destination in and outside Florida. Considering last year's evolution in out of state internet sales and discussions in having nexus in a state where the corporation is not incorporated, AvMap realized in 2019 that having inventory in Florida and shipping out from Florida to customers could be considered having nexus in the state of Florida.

Therefore, in October 2019, AvMap applied for the Voluntary Disclosure Program with the Florida Department of Revenue and submitted DR-1 and "Application by foreign corporation for authorization to transact business in Florida" forms with a filing fee. It was AvMap's understanding that all forms would have been reviewed under the Voluntary Disclosure Program and the Florida Department of Revenue would have forwarded the "Application by foreign corporation for authorization to transact business in Florida" form to the Florida Division of Corporations. AvMap completed the Voluntary Disclosure Program successfully and received a certificate of registration (Florida Annual Resale Certificate for Sales Tax) from the Florida Department of Revenue. As a result, AvMap was under the impression that the company was registered for doing business in Florida. But recently, while trying to file the annual report at sunbiz.org without success, AvMap contacted the Florida Division of Corporations and found out that the "Application by foreign corporation for authorization to transact business in Florida" sent in October 2019 never reached your division and that AvMap is not registered as a foreign corporation in Florida.

AvMap apologizes for this oversight and has enclosed a completed Application. AvMap hopes that under the circumstances, the Division will waive any applicable filing fees.


