FOURTH: These Articles of Dissolution will take effect on June 30, 2004.

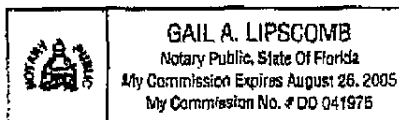
