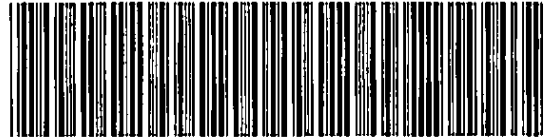



2. The FIRST paragraph of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:


