

On October 28, 2021, we received a letter from your office stating that our Foreign Entity Filing was rejected because the name of the corporation is not available. After speaking with your department on November 2, 2021, I explained that the name which shows on Sunbiz (inactive due to a dissolution) actually belongs to us. We underwent a company restructuring and as a result decided to dissolve the profit company in Florida and started the same company in Delaware, obtaining a new FEIN. However, we plan to continue doing business in Florida as well and would like that name to be released back to us.
