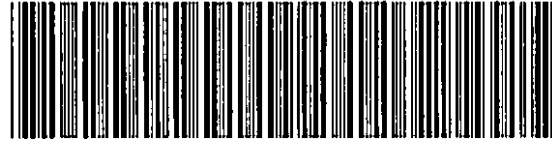

1. That the Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on March 30, 2015, which original Certificate of Incorporation was amended by a Certificate of Amendment filed with the Secretary of State of the State of Delaware on December 29, 2015, which was amended and restated by an Amended and Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on April 29, 2022, was duly adopted pursuant to Sections 242 and 245 of the DGCL.
