I, Timothy M. Bunck, am the sole shareholder in this corporation. The above address and telephone number is my home information.

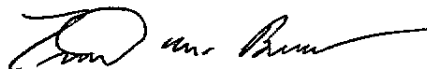
All assets of the corporation were sold to a similar ongoing business November 1998. December 1998 was the last corporate business conducted i.e. payroll and final bills of the corporation paid.
