CERTIFICATE OF INCORPORATION

OF

HARVEST ARMY CHURCH INTERNATIONAL, INC.

(Pursuant to Article 8 of the Religious Corporation Laws)

We, the undersigned, all of full age, pursuant to and in conformity with Article 8 of the Religious Corporation Law of the State of New York, hereby certify as follows:

- 1. That a notice of the meeting of the members of Harvest Army Church International, Inc. for the purpose of incorporating an unincorporated Independent Church was duly given in pursuant of Section 160 of the Religious Corporation Law, and said meeting was held in accordance therewith on the 6th day of August, 1992 at 7:00 in the evening of that day.
- 2. That Rev. Keith Collins was the presiding officer of such meeting, and the following persons, being a majority of the duly qualified voters of said church were present and voted thereat:
 - 1. Rev. Keith Collins Inspector
 - 2. Bertley Hyatt
 - 3. Derron Smith Inspector
- 3. That at such meeting it was determined to incorporate such church as a Religious Corporation in pursuant of Section 161 and Section 162 of the Religious Corporation Law.
- 4. The names and addresses of the persons duly elected as Trustees shall be three, one-third of the number of trustees so decided on shall hold office until the first annual election of trustees thereafter, one-third of such number of trustees to hold office until the second annual election of trustees thereafter, one-third of trustees to hold office until the third annual election of trustees thereafter, are as follows, listed respectively:

- 5. The name of this church shall be Harvest Army Church International, Inc.
- 6. The principle place of worship of said church shall be located in the County of Westchester and State of New York or any other place as the church may deem appropriate.
- 7. The purpose for which this church is to be formed is as follows:
 - A. To establish and maintain one or more places of worship for the purpose of Divine Worship, Spiritual Fellowship and Religious Observances according to the Christian Faith.
 - B. | To reach out, through the preaching and teaching of the Gospel of the Lord Jesus Christ, to the community at large.
 - C. To evangelize throughout the United States and the world sharing the Love and Gospel Of Jesus Christ.
 - D. To train, ordain and license qualified candidates for the work of the ministry of the Gospel.
 - E. To develop multi-service programs in the church and local community to assist in the social, economic, and spiritual maintenance and successful rehabilitation of the family and community based on Christian principles.
 - F. To provide a Christian Bible School for the purpose of ministerial training and education.

- F. To provide a Christian Bible School for the purpose of ministerial training and education.
- G. To procure, by all lawful means of support of the same; to buy vacant land, buildings, alter, develop, build or repair same for the use of the corporation and dispose of the same when no longer needed; To hold and operate such property which shall come into possession of the corporation, all being done under the Religious Corporation Laws of the State of New York.
- 8. The Founding Pastor and Overseer, of Harvest Army Church International, Inc. will be Rev. Keith Collins
- 9. The duration of the church shall be perpetual.
- 10. The Trustees shall be at least three in number or such other number as may be determined at any annual meeting, with Rev. Keith Collins, ex-officio member thereof.
- 11. That in January 1994 and each year thereafter, there shall be held the Annual meeting of the church for the purpose of electing Trustees and other officers and for such other business which shall come before the church at the said meeting.
- 12. Notwithstanding, any other provisions of these articles, this corporation is organized exclusively for one or more of the purposes as specified in section 501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

- 13. No part of the net earnings of this corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except the reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the corporation.
- 14. No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by IRC section 501(h)] or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

15. In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC section 501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of New York.
