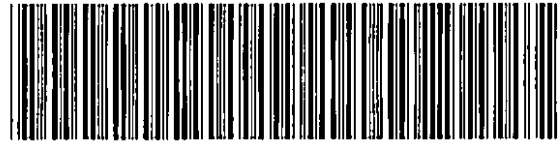

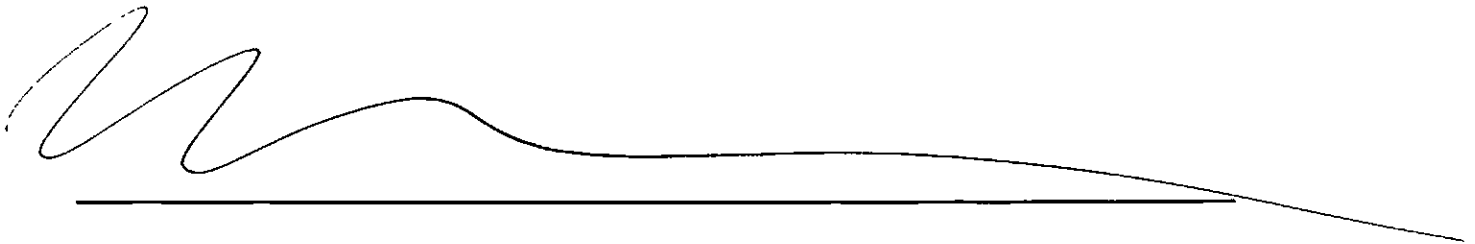

Given these facts, there should be no penalties assessed in connection with its foreign registration per Sections 605.0904 & 605.0905, F.S.

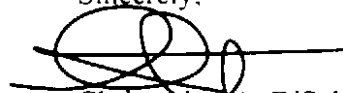

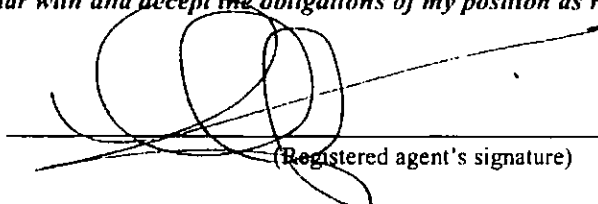
