A photocopy is not acceptable. If the certificate is in a foreign language, a translation of the certificate under oath of the translator must be submitted.
- There is a \$70.00 registration fee and a letter of acknowledgment will be issued free of charge upon registration.
- Certification fees are optional. Please submit an additional \$8.75 if a certificate of status is needed. The fee for a certified copy of the application is \$8.75 each (plus \$1 per page for each page over 8, not to exceed a maximum of \$52.50). Please check the appropriate box on the cover letter and send one check for the total amount made payable to the Florida Department of State.
- The cover letter should be completed and submitted along with the certificate, application and check. Both the mailing address and street address are noted in the cover letter.

ADDENDUM

TO

APPLICATION BY FOREIGN NOT FOR PROFIT CORPORATION FOR AUTHORIZATION FOR TO CONDUCT ITS AFFAIRS IN FLORIDA OF

NEW BEGINNINGS IN CHRIST, INC.

- 8(a) ARTICLE I: The name of the corporation shall be New Beginnings in Christ, Inc.
- **8(b) ARTICLE II**: The corporation shall have perpetual existence.
- 8(c) ARTICLE III: The corporation is organized exclusively for religious purposes and for the specific purpose of conducting a Christian evangelical ministry. In furtherance of this purpose, the corporation shall exercise all of the powers granted to non-profit corporations under the laws of Nebraska except such as may be inconsistent with the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954, or the regulations issued thereunder. (or the provisions or regulations under any corresponding future United States Internal Revenue Law) pertaining to the qualification of the corporation as an exempt organization under Section 501(c) (3) of the Internal Revenue Code of 1954.
- 8(d) ARTICLE IV: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to ;its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purpose as set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt, from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law); or (b) by a corporation, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).


