**CERTIFICATE OF INCORPORATION**

**OF**

**EAST HARLEM FELLOWSHIP**

Pursuant to Article 9 of the Religious Corporations Law

WE, the undersigned, for the purpose of forming and incorporating a free church pursuant to Article 9 of the Religious Corporations Law of the State of New York, hereby certify as follows:

1. The name or title by which the church shall be known in law is "EAST HARLEM FELLOWSHIP".
2. The church is established in New York County with an address at 1620 Lexington Avenue, New York, NY 10029.
3. The purpose of the church is to establish and maintain a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith where Jesus Christ may be honored and worshiped as Savior and Lord, and where the Holy Spirit may be honored according to our distinctive testimony, to assure our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all visible legal means, both at home and in foreign lands.

No part of the income of the church shall inure to the benefit of, or be distributed to, its members, trustees, directors, officers or other private persons, except that the church shall be authorized to pay reasonable compensation for services rendered and to make payments, distributions and gifts in furtherance of and in accordance with its 501(c)(3) purposes. No substantial part of the activities of the church shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the church shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.



In the event of dissolution, all of the remaining assets and property of the corporation shall, after payment of the necessary expenses thereof, be distributed to such organizations as shall qualify under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or to such other organization that will in the judgment of a Justice of the Supreme Court of the State of New York best accomplish the purposes for which this church was formed.
