






I hope this letter finds you well. My name is Joshua Broide, and I serve as the Chairman and President of Partners in Jewish Life, a Michigan Not for Profit Corporation with an Employer Identification Number (EIN) of 83-1579625. I am writing in response to your recent communication, Letter Number 423A00021534, dated September 18, 2023, and referenced as Ref. Number W23000127084.

In your letter, it was stated that our application to file as a foreign corporation in the State of Florida was not processed due to the unavailability of the name in the document application, as it was not distinguishable from the name of an existing entity. I wish to provide clarification and rectify this situation as follows:

Last month, I filed a Florida corporation with the same name, Partners in Jewish Life, Inc. Subsequently, I learned from my accountant that I had filed the incorrect form. To correct this, I contacted the Florida Division of Corporations, who advised that the first step would be to file a Florida Non-Profit Dissolution, which I completed under Document Number N2300009232. This action transitioned the status of the entity from active to inactive.

In light of the above, I am now submitting this letter as a name release affidavit, as advised by the Florida Division of Corporations and includes the following declarations:

- a. I am the Owner of the old entity, Partners in Jewish Life, Inc.
- **b.** I do not have any plans to reinstate the entity.



c. I hereby release the name "Partners in Jewish Life, Inc." to the foreign entity seeking qualification in Florida.
