

Reference is made to your recent letter requesting approval to register the above-referenced name with the Florida Secretary of State. United Commonwealth Bank will be a division of United Community Bank which is a Illinois state-charted bank, headquartered in Chatham. Illinois, and regulated by the Illinois Department of Financial and Professional Regulation, Division of Financial Institutions.

Section 655.922. Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name. Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, this correspondence is not intended to grant the authority to act in any licensed capacity until all licensing requirements have been met within this state. Additionally, should confusion due to the similarity of the name with other financial institutions arise, steps may need to be taken for your institution to alleviate the confusion.


