In January of 1997 Becerra's Export Corporation changed accounting firms. Immediately thereafter I went to Ecuador. During that time I was in a car accident and broke my leg, as well as suffered numerous other injuries. I was unable to return to the United States until the end of June.

Upon my return, I received the 1997 Profit Corporation Annual Report packet and realized that it was past the filing date of May 1, 1997. I am asking that the \$385.00 late penalty be waived, as I was (unavoidably) out of the country during the time it was due. In addition, neither the accountant, nor anyone one else in the company had the authority to prepare this, other than myself and my brother, Jaime, who lives in Ecuador.

Please take these extenuating circumstances into consideration and waive this penalty. Thank you for your consideration. I await your response.
