#### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

FORTUNE FINANCIAL CORPORATION (reflecting name change to Fortune Services, Inc.)

Pursuant to Sections 607.1001, 607.1003, 607.1006, and 607.1009, Florida Business Corporation Act (the "Act"), the following provisions of the Articles of Incorporation of Fortune Financial Corporation, a Florida corporation, first filed in Tallahassee on February 23, 1981 and assigned document number F23262, be and they hereby are amended as follows:

1. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

#### Article I - Name

The name of the corporation is Fortune Services, Inc.

2. The foregoing amendment was adopted by the sole shareholder of the corporation on the 26 Hz day of June, 2000. The only class of stock entitled to vote on approval of the Articles of Amendment was the common stock. The number of votes cast for the amendment by the shareholders was sufficient for approval.
