**ARTICLES OF AMENDMENT

Pursuant to the provisions of 607.1006 of the Florida Business Corporation Act, the undersigned does hereby certify that:

1. The Board of Directors of FDP Corp. (the "Corporation"), by the unanimous consent of its members filed with the minutes of the Board, adopted a resolution authorizing an amendment to Article III of the Articles of Incorporation of the Corporation by deleting the present Article III in its entirety and replacing it with the following:


"Article III. The corporation is authorized to issue one class of stock, which shall be designated as common stock. The total number of shares of common stock that the corporation is authorized to issue is One Thousand (1,000) shares, having a par value of \$1.00 per share."

2. The date of the adoption of the amendment is June 5, 2002.

3. The amendment was approved the sole shareholder. The number of votes cast for the amendment was sufficient for its approval.
