ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MARINSA MIAMI CORPORATION, A FLORIDA CORPORATION



Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:
