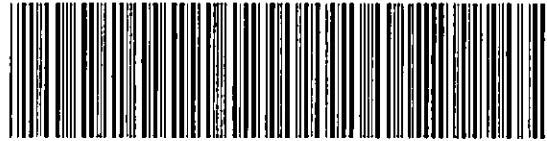

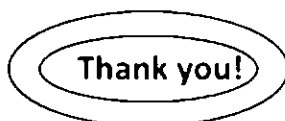

The undersigned certifies that:

1. He is the Chief Operating Officer of CHARLAN, BROCK & ASSOCIATES, INC., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on April 10, 1981, as amended.

2. The following amendment to the Articles of Incorporation was unanimously adopted and approved by the Shareholders (the "Shareholders") and Directors (the "Directors"), by written consent in lieu of a special meeting, dated March 27, 2023. The number of votes cast by the Shareholders and Directors were sufficient for approval.

3. ARTICLE III of the Articles of Incorporation is hereby amended in its entirety to read as follows:
