We have a company that has been inactive and due to an office move in 2003 we did not receive the UBR form. It was administratively dissolved on 9/19/2003. I called to find out how to reinstate the status and the operator instructed me to write a letter about the mailing address, download the reinstatement form and send \$300.

When I downloaded the reinstatement form it says the charge will be \$600 plus \$61.25/year plus 88.75/year or a minimum of \$750. Then below that it says that if it was dissolved in 2003 it will be \$900. Before I do anything I wanted to verify the fee.
