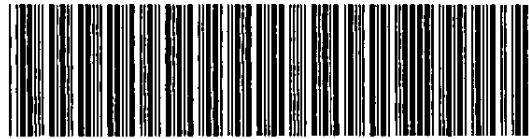



**SECOND:** The date of adoption of the amendment is January 2, 2013.


