Pursuant to Section 607.0704 of the Florida Business Corporation Act, the undersigned, Winn-Dixie Stores, Inc. ("Winn-Dixie Stores, Inc." or "WD") being the sole shareholder of Winn-Dixie Handyman, Inc., a Florida corporation, ("Winn-Dixie Handyman, Inc." or "Winn-Dixie Handyman") hereby consents to and adopts the following resolutions and takes the following actions with the same force and effect as if such resolutions had been duly adopted and such actions duly taken at a special meeting of the sole shareholder called and convened for such purpose, effective this 21 day of November, 2006.

WHEREAS, on February 21, 2005 (the "Petition Date"), Winn-Dixie Stores, Inc. and certain of its subsidiaries filed voluntary petitions for reorganization relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101-1330 (as amended, the "Bankruptcy Code").

**BE IT FURTHER RESOLVED**, that any and all actions heretofore and hereafter taken by any officer of WD that is related to the subject matter hereof, and is not inconsistent with the authorization contained herein in the forgoing resolutions is hereby ratified and confirmed as the act and deed of the sole shareholder.
