
ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION

Pursuant to the provisions of § 607.1003 of the Florida Business Corporation Act, as amended, KERMAN, BLOOM, YAEGER & SPANGLER, M.D., P.A., a Florida professional service corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of this corporation is: KERMAN, BLOOM, YAEGER & SPANGLER, M.D., P.A. (the "Corporation").
