Pursuant to the provisions of Section 607.1006, Florida Statutes, HVIDE MARINE TRANSPORT, INCORPORATED, a Florida corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** Article I is hereby amended to read as follows:
- “The name of this Corporation is Seabulk Transport, Inc.”
