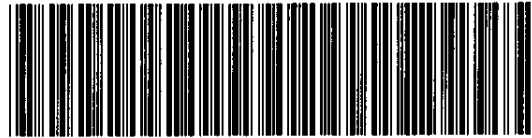

- A. Article I of the Articles of Incorporation of Donahoo, Ball & McMenamy, P.A., is hereby amended to read:


ARTICLE I- NAME OF CORPORATION

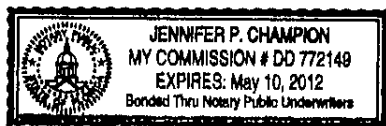
