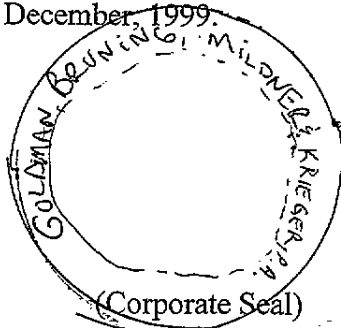
ARTICLES OF AMENDMENT


