ARTICLES OF MERGER

OF

AMERICAN FASTENERS GROUP, LLC, a Florida liability company,

WITH AND INTO

AMERICAN FASTENERS CORPORATION, a Florida corporation

Pursuant to the provisions of Section 605.1025 of the Florida Revised Limited Liability Company Act ("FRLLCA") and Section 607.1109 of the Florida Business Corporation Act ("FBCA"), American Fasteners Group, LLC, a Florida limited liability company, and American Fasteners Corporation, a Florida corporation, do hereby adopt the following Articles of Merger:

- 1. The name, form/entity type, and jurisdiction for the merging party is as follows: American Fasteners Group, LLC, a Florida limited liability company (the "Merging Entity").
- 2. The name, form/entity type, and jurisdiction for the surviving party is as follows: American Fasteners Corporation, a Florida corporation (the "Surviving Entity").
- 3. The Merging Entity is hereby merged with and into the Surviving Entity and the separate existence of the Merging Entity shall cease (the "Merger"). The Surviving Entity is the surviving entity in the Merger.
- 4. The Merger was unanimously approved by (i) the Surviving Entity in accordance with the laws of the State of Florida, (ii) the Merging Entity in accordance with Sections 605.1021-605.1026 of the FRLLCA, and (iii) each member of such limited liability company who as a result of the Merger will have interest holder liability under Section 605.1023(1)(b) of the FLLCA and whose approval is required.
- 5. The Surviving Entity existed before the Merger and is a domestic filing entity; however, there is no amendment to the Surviving Entity's Articles of Incorporation.
 - 6. No member of the Merging Entity is entitled to appraisal rights under the FRLLCA.
- 7. The Merger shall become effective upon the filing of these Articles of Merger with the Florida Department of State.
