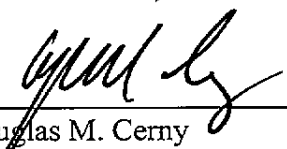
2. The aforesaid Plan of Merger was adopted in accordance with the provisions of the Florida Business Corporation Act on December 18, 1998.

3. Shareholder approval was not required for the merger.

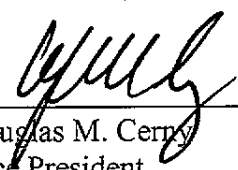
4. The effective time and date of the merger herein provided for shall be 12:00 p.m. on December 31, 1998.

## **PLAN OF MERGER**

1. American Bus Lines, Inc., which is a business corporation of the State of Florida and is the owner of all of the outstanding shares of American Coach Lines, Inc., which is also a business corporation of the State of Florida, hereby merges American Coach Lines, Inc. into American Bus Lines, Inc. pursuant to the provisions of the Florida Business Corporation Act.

2. The separate existence of American Coach Lines, Inc. shall cease at the effective time and date of the merger, and American Bus Lines, Inc. shall continue its existence as the surviving corporation pursuant to the provisions of the Florida Business Corporation Act.

3. The issued shares of American Coach Lines, Inc. shall not be converted in any manner, but each said share which is issued immediately prior to the effective time and date of the merger shall be surrendered and extinguished.

4. The Board of Directors and the proper officers of American Bus Lines, Inc. are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
