**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
TEACHER SUPPORT SOFTWARE, INC.**

TO: Department of State
Tallahassee, Florida 32304

Pursuant to the provisions in Section 607.1003 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on March 17, 1997:

1. The following amendment to the Articles of Incorporation of Teacher Support Software, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on March 17, 1997, in the manner prescribed by the Florida General Corporation Act:

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue without amending these Articles is Twenty Thousand (20,000) shares of \$.001 par value each. All pre-emptive rights of stockholders are expressly reserved. At each election of Directors, each stockholder entitled to vote at such election shall have the right to cast, in person or by proxy, the number of votes equal to the number of shares owned by him for as many persons as there are Directors to be elected, and for whose election he has the right to vote. It is expressly prohibited for any stockholder to cumulate his vote in any election of Directors.

2. The number of shares of the corporation outstanding at the time of such adoption was 15 shares common stock; and the number of shares entitled to vote thereon was 15 shares common stock.

3. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

4. Number of shares voted for the amendment of Article IV was 15; the number of shares voted against such amendment was 0; the number of shares abstaining was 0; and the number of shares not represented at the meeting in person or by proxy was 0.

5. The number of votes cast by a majority of the holders of common stock in favor of the amendment of Article IV was sufficient for approval by the common stock shareholders.

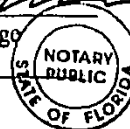



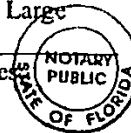
