ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation filed September 30, 1981, F471587

FIRST: The name of the corporation is DONALD SINGER, ARCHITECT, P.A.

SECOND: The following amendments of the Articles of Incorporation were adopted by the corporation:

1. ARTICLE I of the Articles of Incorporation is hereby amended to read as follows:

The name of this corporation is:
SINGER ARCHITECTS, INC.

2. ARTICLE II of the Articles of Incorporation is hereby amended to read as follows:

"This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and Florida."

3. ARTICLE III, subparagraph B, which reads as follows:

"The Common stock of the Corporation may not be issued to anyone other than an individual who is duly licensed to render architectural services. No shareholder of the Corporation shall enter into a voting trust agreement or other type of agreement vesting any other person with the authority to exercise the voting power of any or all of his shares of Common Stock of the Corporation."

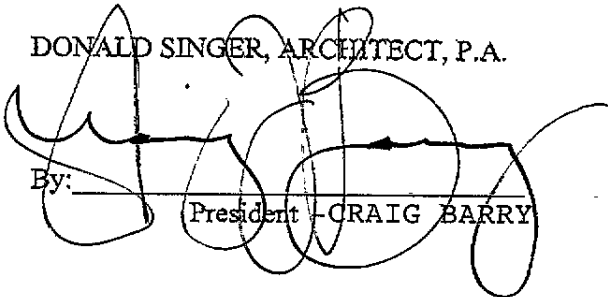

THIRD: The amendments were adopted by a unanimous vote of the Board of Directors on the 1st day of January, 2000.

FOURTH: The amendment was approved by a majority of the stockholders of the common stock of the corporation on the 1st day of January, 2000. This is the only voting group of the corporation, and a majority vote is sufficient for approval.

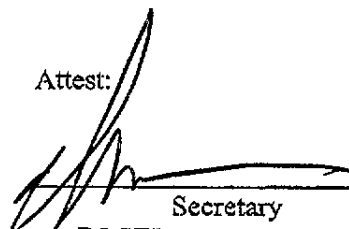
