

**TO THE SECRETARY OF STATE OF THE STATE OF FLORIDA:**

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation executes the following Articles of Dissolution:


**FIRST:** The name of the corporation is Advance Resource Systems, Inc. (hereinafter referred to as the "Corporation").

**SECOND:** The dissolution was authorized as of November 23, 1998.

**THIRD:** The total number of shares entitled to be cast on the proposal to dissolve the Corporation was Seven Thousand Five Hundred (7,500). Seven Thousand Five Hundred (7,500) shares were cast in favor of the dissolution, and this number was sufficient for approval of dissolution.
