I am writing to you because my company is and has been active and I am listed as being dissolved. In 1992 it was dissolved due to chaos with our Hurricane Andrew. It was then reinstated in 1993. In 1994 it shows it was dissolved again but I believe there was a mistake with that. I recall sending back the annual corporate report with check #3968 for \$375.00, written on Sept. 16, 1994.

Upon my going through all my 1994, 1995 and 1996 cancelled checks I did not get that check back. It was not cleared through the bank either, and I do not show that it ever came back. I notified the bank and they said they have nothing on check #3968 and that it must have been lost in Tallahassee along with the 1994 annual corporate return.


