ARTICLES OF DISSOLUTION OF CWC INVESTMENTS, INC.

CWC INVESTMENTS, INC. (INCORPORATED ON OCTOBER 22, 1981)

Pursuant to Florida Statute 607.1043, CWC INVESTMENTS, TWC., a Florida corporation incorporated on October 22, 1981, thereby adopts the following Articles of Dissolution, and sets forth as follows:
