

ARTICLE I - NAME

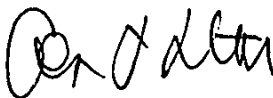
The name of this corporation is: Alan D. Katell, Ph.D., Inc.
