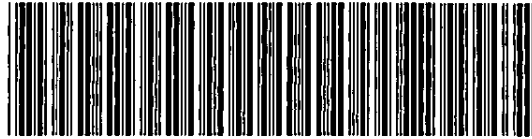

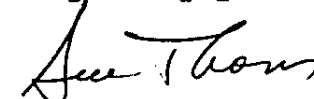

"ARTICLE I - NAME

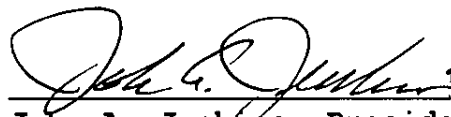
The name of this corporation is PRACTICE MANAGEMENT, INC."
