1. The name of the corporation is MCCOY ENTERPRISES OF ORLANDO, INC. (the "Corporation").

2. The Corporation was formed in the State of Florida on November 2, 1981, under Charter No. F52657.

3. A majority of the shareholders of the Corporation entitled to vote authorized the dissolution of the Corporation pursuant to an Action by Written Consent of Shareholders Without Meeting dated December 20, 1996, in accordance with Section 607.1402 of the Florida Business Corporation Act, and such number cast for the dissolution was sufficient for approval.
