HUNTER COLLINS, D.M.D., P.A.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

1. **Name of the Corporation.** The name of the Corporation is Byron R. Beard, D.M.D. & J. Hunter Collins, D.M.D., P.A.
2. **Text of the Amendment.** The amendment changes the name of the Corporation to Collins & Montz, D.M.D., P.A.

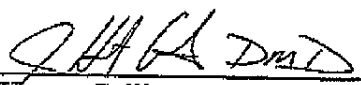
ARTICLE I - NAME
