

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of MARIAN FARMS, INC. (the "Corporation") are hereby amended as follows:

FIRST: Article IV of said Articles of Incorporation is hereby amended by deleting the provisions of said Article IV as the same now exist and by substituting, in lieu thereof, the following:

ARTICLE IV

1. <u>Authorized Stock</u>. The capital stock authorized, the par value thereof, and the class of such stock shall be as follows:

Number of Shares Authorized	Par Value	Class of Stock
10,000	\$1.00	Class A Voting Common
150,000	\$1.00	Class B Non-Voting Common

The consideration for all of the above stock shall be payable in cash, cancellation of debt, property (real or personal), labor or services in lieu of cash; at a just valuation to be fixed by the Board of Directors of the Corporation.

- 2. <u>Voting Rights</u>. The Class A Voting Common Stock shall possess and exercise exclusive voting rights and, at all meetings of the shareholders, each record holder of such Class A Voting Common Stock shall be entitled to one vote for each share held. Shareholders holding Class A voting Common Stock shall have no cumulative voting rights in any election of directors of the Corporation. Class B Non-Voting Common Stock shall possess no voting rights other than as required by law.
- 3. No Preemptive Rights. No shareholder of the Corporation shall have the right, upon the sale for cash or otherwise, of any new stock of the Corporation, of the same or any other kind, class or series as that which he already holds, to purchase his pro rata or any other share of such stock at the same price at which it is offered to others or any other price.

SECOND: Each share of common stock outstanding at the time these Articles of Amendment become effective shall automatically be converted into one (1) share of Class A Voting Common Stock and ten (10) shares of Class B Non-Voting Common Stock. Immediately upon the

effectiveness of these Articles of Amendment, the Corporation will expeditiously coordinate with its shareholders to arrange for the surrender of old shares and the issuance of new ones.

THIRD: Authorization for and the recommendation of approval for the foregoing Articles of Amendment was obtained pursuant to a joint written action of the Board of Directors and the Shareholders taken without a meeting dated December <u>20</u>, 1996, pursuant to which all shares were voted in favor of the action.
