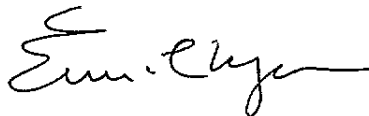

ARTICLE I - NAME

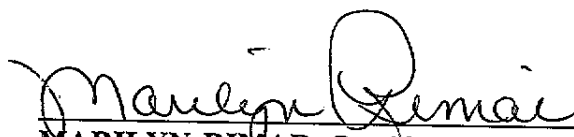
The name of the Corporation shall be **MDR EQUITIES, INC.**
