

1. The Name of the corporation is: Information and Display Systems, ("Corporation").
2. The date of filing of the Articles of Incorporation of the Corporation was November 25, 1981 as amended on August 3, 1998, and assigned document number F56988.
3. The Corporation amends its Articles of Incorporation by changing its name to Squarefoot Partners, Inc. Article I of the Articles of Incorporation is amended to change the name of the Corporation to Squarefoot Partners, Inc., effective immediately.
4. Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.

These Articles of Amendment to the Articles of Incorporation were approved by the Shareholders and the Board of Directors of the Corporation on January 30, 2012. The number of votes cast in favor of this Amendment was sufficient for approval.
