

No debts of the corporation remain unpaid.

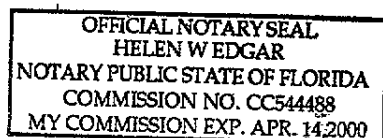
**SEVENTH:**
