Ladies and Gentlemen,

I am writing this letter to request penalty relief regarding my late filing of the 2002 Uniform Business Report. I have no recollection of this ever happening in the past during the 20 years of our incorporation.

Somehow the form was put into my Registered Agent (attorney) file since the Report is mailed to us from his office. We don't often use his services so once in that file, it may be months before the file is opened.

Our business is small (4 employees). I have been behind in bookkeeping due to being overworked in my other responsibilities. Personal health problems have also slowed things down and resulted in my having to devote much of my day to current matters. While doing bookkeeping/accounting tasks for 2002, I happened to notice the absence of the fee in the general ledger account where it should be posted. That led me to the attorney file where the document was found.

I called the Division of Corporations office this morning and the attendant told me to send in the Report together with the regular fee and a letter. My business is not a highly profitable one. I have been able to take only a very small salary for many years. If this was anything other than a "personal" business, we would have closed our doors at least 5 years ago. A \$400.00 late fee is a very significant expense and represents cash which is very important to our business. I regret this oversight and not having the time to get it all done "on time" and without an occasional error. We do a good job at supplying our customers. I would say, that with only four employees, we do an extraordinary job, but during our often frenetic pace occasionally something slips off my desk and into the wrong place as was the case with the Report.

Thank you for your consideration. I will be happy to answer any questions you may have and I appreciate your attention and will follow your decision. Penalty relief would be greatly appreciated. Thank you.
