Please accept this application for reinstatement. I have just received the application for reinstatement and have not to date received any of the original forms. I am asking for leniency in that I have not received the report forms at our address.

Our town has had address changes 4 years ago that changed our address from 2697 E Silver Springs Blvd to 2697 NE Silver Springs Blvd. While most of our mail has continued to be delivered as before, we have noticed that some brochures, etc have been sent elsewhere and were never received by our office. There is another travel agency located a half mile away from us - also on Silver Springs Blvd (Ocala Travel) that has received many of our documents and packages since the address change.

We have only recently been made aware of the addition of the "N" to our address after pursuing travel documents for a client and having to track them down.
