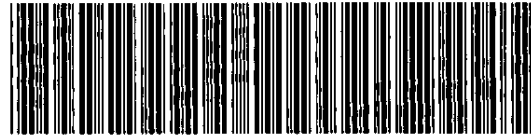

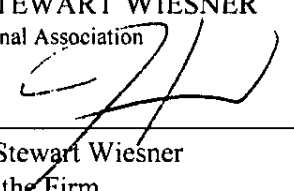

2. The foregoing amendments were adopted Directors of the Corporation on August 2, 2010 and by the Stockholders of the Corporation on August 2, 2010.

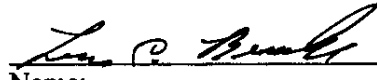
