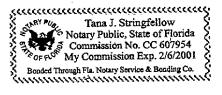

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

JAX MARINE, INC.



Pursuant to the provisions of §607.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Jax Marine, Inc.
- 2. The following amendments to the Articles of Incorporation were adopted by written consent of the shareholders of the corporation on February (2), 1998:
