

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AMERICAN LIFESTYLE, INC.



AMERICAN LIFESTYLE, INC., a corporation organized and existing under the laws of the State of Florida, under certificate number F66454, filed in the office of the Secretary of State on February 3, 1982, hereby certifies as follows:

1. The director and shareholder considered amending the Articles of Incorporation so as to recapitalize the corporate structure by changing the authorized number of shares of stock to ONE HUNDRED THOUSAND (100,000), and to provide for a par value of \$0.01. After discussion, it was

RESOLVED, that the Articles of Incorporation of AMERICAN LIFESTYLE, INC. be amended so as to increase the maximum number of shares of stock authorized to ONE HUNDRED THOUSAND (100,000) and to decrease the par value to \$0.01 per share, and that Paragraph A of Article V shall be amended to read in its entirety as follows:

"ARTICLE V - CAPITAL STOCK

- A. This corporation is authorized to issue ONE HUNDRED THOUSAND (100,000) shares of common stock having a par value of One Cent (\$0.01) per share. FIVE THOUSAND (5,000) of said share shall be designated and known as voting common stock and NINETY-FIVE THOUSAND (95,000) of said shares shall be designated and known as nonvoting common stock. Except for voting rights, all shares of common stock shall be subject to the same rights and shall be in equal in all other respects."
- 2. These Articles of Amendment were approved by the sole director of the corporation and by the sole shareholder by joint written action dated MARCH 23, 1999.
