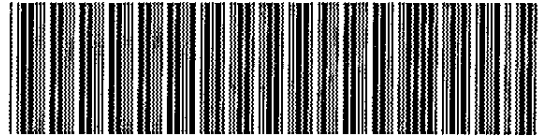

NAME

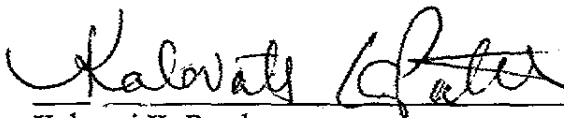
The name of the corporation is JALARAM HOTELS, INC.
