





The undersigned subscribers, IVES M. CARY and ELLA MAE CARY, natural persons competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the proposed corporation is CONFIDEX COMPANY, INC.

ARTICLE TWO

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE THREE

The total number of shares of stock which the corporation shall have authority to issue is ten thousand, which shall be of a par value of one dollar per share.

ARTICLE FOUR

The corporation will begin business with capital in the amount of Five Hundred Dollars (\$500.00).

ARTICLE FIVE

The corporation shall exist perpetually and shall begin the 1st day of March, 1987.

ARTICLE SIX

The initial address of the principal office of the corporation is Jupiter Inlet Colony, Jupiter, Florida 33488.

ARTICLE SEVEN

The names and addresses of the subscribers are:

ARTICLE EIGHT

There will be no directors. The affairs of the corporation shall be managed by the stockholders rather than by a board of directors and all questions shall be determined by vote of the owners of a majority of the outstanding shares.


ARTICLE NINE


The corporation is authorized to issue only one class of stock. Stock shall be issued and transferable only to natural persons who are not non resident aliens.

ARTICLE TEN

In case one of the stockholders desires to sell his shares of stock, he must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in the purchase of such shares; and any attempted sale in violation of this provision is null and void. A stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the corporation, stating the terms of sale, and unless his terms are accepted by one or all of the stockholders within thirty (30) days thereafter, they shall be deemed to have waived their privilege of purchasing and he will be at liberty to sell to anyone else.


