## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DEVELOPMENTAL SERVICES, INC.

The undersigned, Kenneth H. Schultz, Secretary of DEVELOPMENTAL SERVICES, INC., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:
