The corporate office of the corporation shall be located at **2975 Overseas Highway, Marathon, Florida 33050.**

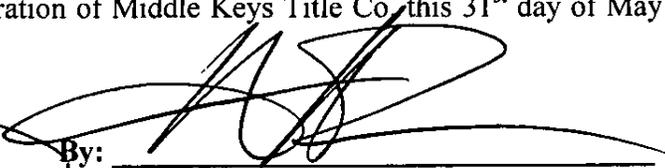
**ARTICLE VIII - INDEMNIFICATION.**

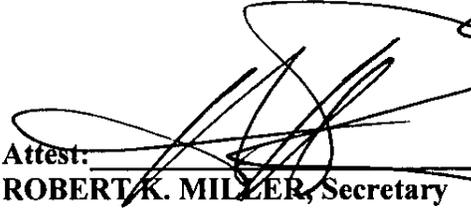
This corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

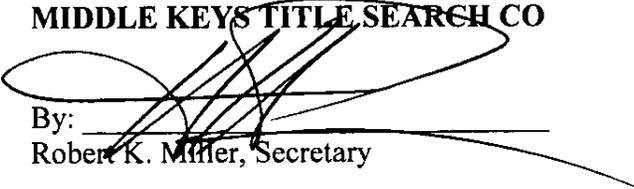
